1.SELLER'S DECLARATION AND WARRANTY:

1.1 The SELLER declares and warrants to the BUYER that as of the date hereof, all information of any nature regarding the Good, as described herein, is accurate and complete. Furthermore, the SELLER acknowledges that the BUYER relies on it to conclude the transaction on the terms set forth herein. Without this warranty, the BUYER would not have entered into this transaction.

A) The Good unequivocally belongs to the SELLER. The SELLER has valid and negotiable title to it, free from any lien of any kind whatsoever except as noted herein:

B) In addition to the statements expressly set forth in paragraph 1.1 and its subparagraphs, ***this sale is made without any warranty of any kind, at the BUYER's risk, without legal warranty*** except as noted herein:

2.BUYER'S ACKNOWLEDGEMENT:

2.1 The BUYER acknowledges that the SELLER is not a professional seller.

2.2 The BUYER acknowledges having inspected or having had inspected the Good or having refused the inspection of the Good, accepts it in its current condition, and acknowledges that this sale is made at their own risk. For this purpose, Annex 1 is an integral part of the contract.

3.SALE OF THE GOOD

3.1 The SELLER sells to the BUYER, on the terms set forth herein, the Property, as well as any warranties and indemnities concerning it, which the SELLER may hold (RIGHTS) and which may be assigned by the SELLER (said assignable RIGHTS being deemed, for the purposes hereof, to form part of the Good).
